Dear Colleagues,

In a recent meeting, we discussed how important it is to look out for each other. Students and staff are under tremendous stress and are experiencing some form of trauma. We may not recognize the trauma we are experiencing so it is important we each look out for one another. If you notice a change in a coworker, please reach out to him/her. It is very important to care for each other's well-being. Our jobs can be very challenging and trauma can sneak up on you without you realizing it. #### **Supreme Court Alert!**

I love our new contracts. Mine has given me some financial incentives I would not have had without the long hours invested by our many levels of Union representation. I can only imagine the expense involved in crafting and reviewing those documents and I want to be a part of paying for the best minds available to get it done fairly and correctly. My dues were a very small investment in that process which has delivered a healthy return.

How ironic it is that as our contracts were being finalized, our US Supreme Court agreed to hear a case which will determine whether or not unions can continue to collect the agency fee. Friedrichs v. California Teachers Association aims to overturn a nearly 40-year precedent which allows the use of agency fees for public sector unions. Union members must pay for the costs associated with collective bargaining and contract administration which benefit non-members as well, so nonmembers pay an agency fee as their fair share. The agency fee represents just the portion of the dues that was committed to the expenses involved in contract negotiation and implementation. Any portion of dues devoted to political action or lobbying are not included in the agency fee. It was a fair arrangement. Everyone who benefits from a contract helps to pay for it, but only those who support the Union as a whole pay full dues as members.

From its beginnings, this case has been specially crafted for the Supreme Court, and if successful would affect tens of thousands of union contracts and would force millions of public employees into a right-to-work model.

Justice Alito has been inviting a case like "Friedrichs" for several years, and anti-union groups have been paying attention. The right-to-work argument is that there is political activity done during contract negotiation and subsequently related to contract enforcement and it has already been determined that non-members cannot be required to pay for political speech. Another tactic will be to use the First Amendment's guarantee to freedom of speech, insisting that individuals have the right to bargain with their employers individually.

If the Court rules against unions' abilities to collect agency fees it could devastate our financial capacity to negotiate contracts. Even worse, it would set up a divisive workplace where members would most likely be resentful that non-members are getting the same benefits without contributing toward the cost of having gotten them. That's assuming that we would have enough resources to continue to negotiate at all.

If this comes to pass, we all must make the effort to talk to each other about our honest feelings on these matters. Through open and ongoing dialogue, grounded in the history of what the labor movement and our Faculty Association has accomplished, we will be able to convince each other that our future needs to be funded by us all.  $10/15 - Page \ 3$

#### **October Checklist**

**Put the beep where you sleep:** Smoke alarms are the theme of this year's Fire Prevention Week (October 4-10). Position them on ceilings or high on walls in each bedroom and in the hall adjacent to the bedrooms.

**Evaluate yourself for ADHD:** October is Attention Deficit/Hyperactivity Disorder Month. Check for adult ADHD symptoms at AD-DAdult.com/getting-help/for-you/online-screening-test.

Photograph fall foliage: Overcast days are best for capturing color. Fog and mist add mystery. Look for autumn reflections in ponds and streams. For unique photos, shoot trees from above—atop a hill, promontory, etc. Photograph the same tree every few days to document the change.

**Fight seasonal depression:** Eat foods rich in omega-3s (such as salmon, sardines, walnuts) and tryptophan (pumpkin, spinach, turkey). Avoid processed foods. If you often suffer from winter blues, talk with your doctor about using a phototherapy light box as the days get shorter.
