New Business:

Capital Region BOCES Board Meeting -

Susan Kusalonis and **Jim Reed** (TA, SPED) attended the Nov. 17th meeting.

- Various Board Committee reports were commented on.
- The <u>Professional Development Work Plan</u> was presented by Kathy Collins (Teacher, SSS) and Tracy Gyroekae (CTE). It was well received by the Board.
- Budget Presentation by Mark Jones: one of their goals is to save 20% in Overhead & Maintenance costs (turning off lights when a room is not in use, etc.)
 Budget increase will be kept within 2% range; contest among component districts as to who can be most energy efficient; it is critical that we communicate our efforts to cut costs to the districts. Current Operation Budget Increase \$84,000, operational expenses have been reduced by \$17,500. (These notes on budget are from memory, not given a hard copy to review.)

Dear Gabby,

I am a member of the Service Unit and the teacher that I work with tells me that one day a year is automatically contributed from my time to the sick leave bank. I thought I could decide whether or not I wanted to contribute to the sick leave bank. What's up with that?

Dear Symptom free,

Gabby is so glad you raised this issue. Given that our Association negotiates three separate contracts with BOCES, it is very easy to get confused about what each contract says. Let's review:

The **Service contract** (pp. 45-46) states that members "**may** contribute personal sick leave credits to a pool to be used to provide additional sick leave to members of the bargaining unit in the event that current and accumulated sick leave is exhausted and illness continues."

The **TA/EA contract** (pp. 25-26) has similar language except that a TA/EA must have more than one year of service in the BOCES to access the sick bank.

In both contracts, there is language about how and when to contribute, and both state that you must be a contributing member to access the sick bank of your unit.

The **Teacher contract** (pp 54-55) is different, in that the contribution of days is **automatic**. All members are contributing members.

Confused? Please contact your Chapter Vice President (find contact info in your TRIAD every month). If you don't have a copy of your contract, please let your Chap VP know. Gabby

Dear Gabby,

I have worked in a BOCES class-room as a speech/language pathologist for 5 years. This year I am working in a component district. I have been told that I need to work as long as the district teachers work instead of the 6 hour day I worked in the BOCES classroom.

Dear Exhausted,

You have stumbled on a little known part of the **Teacher Unit contract**. Yes, as long as you were assigned to a BOCES classroom as **support service personnel** (see page 28 of the contract) you "shall be on duty for six hours per day as designated by BOCES." However (and now you need to turn to page 29 of your contract) you are now working for a component school district as an **itinerant teacher**. This changes your workday. Now you "shall work on the days and hours scheduled by the component school district where you [they] are assigned."

On another note, it has come to my attention that there is some confusion on the evaluation pilot. In Special Education, each principal will have twenty Teaching Assistants they will be evaluating. This will include both tenured and non-tenured TA's. All non-tenured Teaching Assistants will have a Supervisor Evaluation. The tenured Teaching Assistants will have the option of choosing from the Supervisor Evaluation, a Growth Plan (formerly called self-evaluation) or the Alternative Project Based. At Career and Tech all Teaching Assistants will be evaluated once again this year for the pilot. Last year there was not enough information to determine what areas of the evaluation may need to be amended. The Evaluation Committee wants to ensure that once this process is fully implemented it will be a successful model for both the Teaching Assistant and the Administrative staff. On November 24th, the Administrative staff will meet with the committee for an informational update. Another session will be held on December 12th at the TRE Center from 3-5 PM to assist Teaching Assistants with entering their data into Timekeeper. If you are encountering difficulty please take advantage of this opportunity for assistance. You must have a current password to enter your data into Timekeeper. If your password must be reset, contact Gretchen Wukits (862-4914) or go through GroupWise and she will reset your account.

An e-mail was recently sent to you regarding Excelsior College. Excelsior College has offered to waive the portfolio fee to all BOCES entrants. This could be a tremendous opportunity for all Level I, II, and III Teaching Assistants to achieve the credit hours necessary for certification. For all TA's who are interested in pursuing a degree through an Excelsior College program, please check your email from Kathryn Gerbino on November 12th. All the links to the college are located in the e-mail.

Ad Campaign Urges Congress To Pass Employee Free Choice Act

A new nationwide TV ad campaign launched on Nov. 16 is intended to build momentum behind efforts to pass the Employee Free Choice Act when the new Congress convenes in January. The campaign is sponsored by the workers' advocacy group, **American Rights at Work**. The Employee Free Choice Act would help level the playing field for workers by giving them a fair and direct path to form unions, and it also would help employees secure a contract in a reasonable period of time and toughen penalties against employers who violate the law. A poll conducted earlier in November by Peter D. Hart Research Associates found strong support for the act: 60 percent of voters said it is important to pass it. It's not too late to join the more than 1 million people who already have signed **a petition** that calls on the new Congress to immediately pass the legislation, and the new president to sign it, when they take office in 2009.

Greetings Retirees,

During the past few months, we have received three important letters regarding our health care benefits. The first, from BOCES was our yearly October letter giving us the option to change our insurance carrier. It also informed us that those with the NYSHIP plan would have a \$2 co-pay increase and that the cost of some medications would also increase. Other changes in services or payments were listed.

The second letter, also from BOCES, contained new benefit cards which become effective on January 1, 2009. We were formerly "A" and are now "D".

The third letter was from the State of New York Civil Service Division. It stated that we do not have to change to Medicare Part D for prescription coverage since our NYSHIP Empire plan has adequate coverage. The letter should be saved to avoid penalties if we change plans in the future.

Some good news. There will be an approximate \$63 increase in our Social Security in January. That, along with our \$30 pension increase, will give us \$93 more per month to offset the health care increases.

In spite of the ever-changing complexities

of our lives, we are Blessed to be living here in America and in this 21st century.

During one of my sleepless nights, a talk show minister on my radio companion gave an interesting perspective. He said that we have a far better life than royalty of olden days and the very wealthy of the 17th and 18th centuries. Was there a king who could feel the wonderful relief of walking into an air- conditioned building on a hot summer day? Could he touch a switch and have instant light and heat? Could he enter a supermarket and select from 1000's of delicacies? Could he have a minor malady attended to and medicated, to prevent an early demise? Attention

OK, it is mid December and I am still not really sure what I am <u>supposed</u> to be doing. So far I have come to both the October and November Faculty Association meetings and the food is good and the meetings are interesting, but...... What about me? Should I be saying anything?...Sometimes I don't even know what they are talking about.

Rep Council Rookies do not fret! You are doing fine! You came to the first two meetings! Here are a few more tips to make you feel more comfortable and to help launch your Rep Council service.

- Keep coming! It is important that you try to attend every Rep Council Meeting. If you cannot attend, contact your Chapter Vice President so she can arrange for an alternate. The alternate can vote in your place. Frequently, motions are passed by only a few votes so it is important that your Chapter is represented.
- Prior to every meeting you should be getting the meeting agenda and the minutes from the previous meeting in the mail. Minutes from the Executive Board meeting are also usually included. The agenda also indicates where the meeting will be held, the time and date. Try to bring these documents with you, but if you forget there are usually copies at the meeting. The agenda has space for notes. Some Reps distribute the minutes to their constituents which is easy to do if you work in the same building. Abbreviated Rep Council minutes are printed in the TRIAD.
- Make an effort to contact your constituents so they know who is representing them at Rep Council.
 One idea is to contact them via phone and request their personal email address. Introduce yourself as their Association Representative and ask if they have any issues for you to bring to Rep Council or

questions related to the contract. Keep your constituents informed of pertinent information and issues. GroupWise should not be used for Association communication.

- Every new Rep received a Rep Council Binder. Bring it to Rep Council because it contains...."Useful Information" such as notes on Robert's Rules of Order and Parliamentary Procedure; copies of your Unit Contract and the Association Constitution; forms to request funds from the Philanthropic Fund, forms used to make a motion (motions need to be submitted in writing) and a mileage form. Reps can be reimbursed for mileage to attend Rep Council meetings. (Consult Travel Expense Policy on the back of the mileage form.)
- At the meeting, try sitting with a veteran (Rep Council member) so he/she can help you out, answer some questions. However do not hesitate to raise your hand and ask a question.
- Serve on a committee. Come on, you can do it! Consider serving on one of the many committees: the newly formed Conference Committee, the Website Committee, the Budget Committee, the Nomination and/or Election Committee, the Health and Safety Committee, the Social Committee, the Celebration Bash Committee
- Upcoming conferences are announced in the TRIAD or information is available from your Chapter VP. Look for a conference that might interest you and request to attend.
- Attend your Chapter meeting. The Special Education Teacher Chapter Meeting is held prior to Rep Council Meetings. Look for announcements for your Chapter Meetings.

Special Ed. Teacher Unit Meeting Minutes—November 19th

Topics discussed:

- With the lack of teacher subs, what should be done when a crisis occurs in the program when the teacher is out? One suggestion discussed was to develop a written Crisis Plan for staff to follow in the event of a crisis. This plan would include who to call first, what to do if that person is not available, and when to contact the host building principal. All agreed that the BOCES Principle would be the first person to call in the event of an emergency. All members of the classroom team should be involved in developing the crisis plan including the BOCES principal.
- The issue of the length of the teacher school day is still being discussed with the appropriate parties involved. There were no new developments.
- The issue of new employee training was raised. Are new employees trained on the importance of confidentiality? Is the topic of appropriate behavior within the host school addressed? It is important for BOCES employees to understand that making negative comments about their colleagues, students, or program in front of members of the host district reflects poorly on the organization. Creating a positive relationship with the host school is vital in order for our programs to continue to be productive and well received.

The next Special Ed. Teacher Chapter Meeting will be **Wednesday**, **December 17th** at 3:30 PM at the School Support Services Building. Please come to discuss any of the above issues or a topic you feel needs to be addressed.

FLU SEASON COMING SOON! BE PREPARED!

The hot days of summer are gone, and the warm days of fall get us prepared for cold winter days and flu season. Fall is the time to take preventive action for the flu by getting your flu vaccination. Flu is a serious contagious disease. Getting a vaccine is very important for people at high risk for serious flu complications including young children, pregnant women, people 65 and older and people with chronic health conditions. Each year in the United States more than 200,000 people are hospitalized from flu complications, of which 20,000 are children under 5 years of age. The number children affected by the flu could be reduced according to the Centers for Disease Control and Prevention, if parents were more informed.

A recent survey by the CDC found that only 10 percent of parents knew that the CDC recommends the flu vaccinations for children from 6 months through 18 years; ninety percent of parents didn't know that a child can be contagious for more than seven days after becoming sick; a majority of parents (52 percent are only slightly or not concerned at all that their child or children will catch the flu in the next 6 months; nearly 60 percent of parents have not gotten their children vaccinated against the flu in the past two years; and most parents who don't get their children flu vaccinations say they don't think flu shots are necessary. The results of this survey have clear implications for students and staff in

our schools.

The CDC says to take three steps to fight the flu:

- 1. Take time to get a flu shot.
- 2. Take everyday preventive actions like covering your nose and mouth with a tissue when you cough or sneeze, and throw the tissue in the trash after you use it.
- 3. Take flu antiviral drugs if your doctor recommends them.

"I recommend that all school staff follow the CDC directives to get flu shots because schools are so densely populated and a good breeding ground for flu and other illnesses," said AFT health and safety staffer Darryl Alexander.

Good to Know!

Whether you are a new educational professional or have had many years of experience, it is important to protect yourself in the educational setting. NYSUT has published an excellent brochure entitled: "What You Need to Know About Protecting Yourself". The entire brochure is available from NYSUT by calling 1-800-342-9810 (ask for the Publications Department) or by contacting one of the Triad Co-Editors. An excerpt from the brochure on "Touching Students" was published in the November TRIAD. This month we are publishing the following excerpts: Notes and Jokes, Handling Money and Alone with Students.



Here are a few examples of situations that could confront any school employee and, if common sense isn't used, career-threatening consequences could result.

Notes and Jokes: Personal notes should never be written to students unless they deal solely with educational matters. Notes and jokes can get you into trouble and should be used, if at all, within the educational context of your assignment.

Handling Money: Regardless of the circumstances, do not handle money unless you first understand the procedures required by your district for doing so. Consult your contract, your union representative and your principal. No matter what kind of employee you are, at some point in your education experience, you will be asked to handle money. It might be as simple as holding lunch money for some student or as significant as managing the school store or being in charge of a major fund-raiser at your school. If the procedures for handling money are not in writing, you should do your part to get them reduced to writing, and then follow the procedures exactly. Sometimes it is hard to draw a distinction between mishandling and misappropriating. Be careful when you handle money; never commingle or mix school funds with your own.

Alone with Students: Do not place yourself in situations outside the educational setting of your school where you could be alone with a student. This includes addressing the personal care needs of a student, giving a student a ride in your car, taking a student home with you or taking a student to a movie or camping. Any time you are alone with a student, you are at a greater risk than when you are with a group of students and/or in the presence of adults. If there is an allegation of misconduct between you and the student, and there are only two witnesses-you and the student-what really happened no longer becomes the issue. The issue becomes credibility-whose version of the incident is more believable.
