Presentation of the **NERIC and SSS budgets** for next year. No big issues-both divisions are trying to keep costs down, add new incentives, programs and continue to deliver their services. Money has been saved by the new restructuring within divisions, internal changes and cost savings.

**NERIC** continues to grow **and SSS** management is now offering Labor Relations, TPA Services and Energy management Consortium for 7 schools. Instructional services will be offering Tech Valley HS Dissemination, New EAP service, more intervention, inquiry based learning and information literacy skills, supplemental ELA and Math and comprehensive services for instruction and curricular planning. Both divisions are diversifying services, searching out new opportunities and building new relationships.

**Tech Valley High** is to offer more options for component schools and others for training of staff and become more of a resource for the region. Different groups are using the **BOCES Communication Service** due to its fast and professional services.

There was a discussion on the **Cyber Crime within our BOCES**. Meetings have been held with District's Superintendents and BO-CES is tapping into Cyber fraud units and the State Police to assist the districts to prevent any further crimes and protect themselves, as is BOCES, itself.

There are seven **Superintendent openings** within our BOCES and most will be using our BOCES consultant search process.

**Next meeting:** The Career/Tech and Special Education Budgets. It is being held at the BOCES Board Room, 900 Watervliet Shaker Road, beginning at 5:30 PM for Budgets and 6:30 PM for regular meeting.

Lastly, I was in contact with NYSUT Legislative representative, Peter Savage, for an update on the 55/25 incentive being offered for this school year. [This would allow certain individuals age 55 and older with at least 25 years of service to retire with no reductions, if retirement occurs within an established window.] Peter reported that the bill has been formalized and will be presented to the Legislative for enactment by (Feb. 1-6). He reported the legislation for this bill should be in effect by the end of March. NYSUT, however will be pushing to have this bill passed as quickly as possible due to the short window of time until the end of the school year. I also asked if the 55/25 would be extended for the next school year but unfortunately this initiative is a one-time proposition. I will keep you updated as soon as I have more information. In the meantime, please check out NYSUT's website at www.nysut.org for all legislative information and updates.

## **RETIREES CORNER**

### Hello Retirees,

As we have read in the New York Teacher and the January TRIAD, health insurance benefits (HIBs) for retirees are permanent. For the past 15 years, it has been an annual struggle by the public employees unions to convince our legislators to pass the moratorium to prevent any changes in retiree benefits and the possibility of them being reduced, revoked or negotiated away. This had occurred in some districts in western New York. The new legislation guarantees that HIBs cannot be revoked, however they could be diminished in the future. The legislation states only that they cannot be reduced to less than those received by the work force.

According to our Association contracts, new employees hired after June 30, 1984, will pay 20% of their health insurance premium. This leaves the door open for the possibility of retirees having to pay 20% of the premium as well, if it were to be negotiated in the future. Retirees cannot participate in negotiations since the Association only represents those in the work force. Currently, health insurance benefits are fully paid upon retiring. Both dental and optical coverage are terminated upon retiring. However, COBRA allows new retirees to continue this coverage for 18 months if they pay the premiums in full.

The possibility of having to pay a portion of our premium is a concern for those who retired long ago and have seen their savings diminish through the years.

The premium cost of 20% to employees, ranges between \$73 and \$89 per pay, or \$1,453 to \$1,778 annually, at this time and depending on the specific plan. This may be seemingly a small amount considering that, the salary for a first year teacher with a B.S. degree on Step I is \$40,841. In contrast, those long retired have a much lower annual income.

In the October 2009 issue of the TRIAD, we reported on the income of those who have been retired for 20 and 25 years. TAs who retired in 1985 and rely only on their pension and Social Security, receive an average annual income of \$22,851. Teachers who retired in 1985 receive \$28,516 annually, a pension of \$14,500 and Social Security of \$13,836. Having to pay 20% of the HIB premium would be an additional hardship for those who are already living close to the edge.

The contracts for Teacher and Service will expire on June 30, 2010, and preparations for negotiations have begun. We are placing our confidence and trust in those who negotiate, that they will work to keep our HIBs as they are, fully paid.

In the future, when they retire, they will know what a wonderful benefit this is and appreciate the work of those who came before us in obtaining and maintaining it through the years.

### ARE YOU ELIGIBLE FOR THE EARNED INCOME CREDIT?

The earned income credit (EIC) is a refundable tax credit designed for low-income families and individuals. The EIC varies depending on your level of income and how many dependents you support. There is even the possibility that the tax credit can generate a tax refund larger than the amount of federal taxes you paid had withheld. If you qualify for the EIC, you can opt to receive part of the credit in your paycheck during the year through the Advanced Earned Income Credit (AEIC) instead of waiting until tax time to receive the entire amount.

To be eligible for the EIC, a worker must meet flowing criteria: Must have a valid Social Security number; must be U.S. citizen or resident alien for the entire year; cannot use the married filing separately filing separate; cannot be claimed as a qualifying child by someone else; cannot claim the foreign earned income exclusion (relates to wages earned while living abroad); you and your spouse (if married) are between the ages of 25 and 64.

The rules for qualifying children for the purpose of claiming the EIC are slightly different from the rules for dependents, which means that it may be possible that your child qualifies as a your dependent, but not EIC; or would qualify you for EIC even though the non-custodial parent claims the dependent. Qualifying children must meet the relationship test (birth, marriage, adoption and foster arrangement); the age test (18 or younger at year's end or 23 or younger full-time student) and residency test (child must live with you for more than 6 months and live in the U.S.). All children must have valid Social Security numbers.

Go to the **IRS web site** to see if you should file for the EIC.

### **Healthy Living; Living For Good Health**

#### And You Thought Only Adults Made New Year's Resolutions?

New Year's Eve has always been a time for looking back to the past, and more importantly, forward to the coming year. It's a time to reflect on the changes we want or need to make and resolve to follow through on those changes. The top resolutions for 2010 always seem to be the usual--get out of debt and save more, lose weight and exercise. Learn something new, help others, get organized and spend more time with family also top the list. But New Year's resolutions aren't just for adults.

The following New Year tips are from the American Academy of Pediatrics (AAP) from December, 2009.

#### Preschoolers

I will clean up my toys.

I will brush my teeth twice a day, and wash my hands after going to the bathroom and before eating.

I won't tease dogs – even friendly ones. I will avoid being bitten by keeping my fingers and face away from their mouths.

#### Kids, 5- to 12-years-old

I will drink milk and water, and limit soda and fruit drinks.

I will apply sunscreen before I go outdoors. I will try to stay in the shade whenever possible and wear a hat and sunglasses, especially when I'm playing sports.

I will try to find a sport (like bas-

ketball or soccer) or an activity (like playing tag, jumping rope, dancing or riding my bike) that I like and do it at least three times a week!

I will always wear a helmet when bicycling.

I will wear my seat belt every time I get in a car. I'll sit in the back seat and use a booster seat until I am tall enough to use a lap/shoulder seat belt.

I'll be nice to other kids. I'll be friendly to kids who need friends – like someone who is shy, or is new to my school

I'll never give out personal information such as my name, home address, school name or telephone number on the Internet. Also, I'll never send a picture of myself to someone I chat with on the computer without my parent's permission.

#### Kids, 13-years-old and up

I will eat at least one fruit and one vegetable every day, and I will limit the amount of soda I drink.

I will take care of my body through physical activity and nutrition.

I will choose non-violent television shows and video games, and I will spend only one to two hours each day – at the most – on these activities.

I will help out in my community -

through volunteering, working with community groups or by joining a group that helps people in need.

I will wipe negative "self talk" (i.e. "I can't do it" or "I'm so dumb") out of my vocabulary,

When I feel angry or stressed out, I will take a break and find constructive ways to deal with the stress, such as exercising, reading, writing in a journal or discussing my problem with a parent or friend.

When faced with a difficult decision, I will talk with an adult about my choices.

When I notice my friends are struggling or engaging in risky behaviors, I will talk with a trusted adult and attempt to find a way that I can help them.

I will be careful about whom I choose to date, and always treat the other person with respect and with-out coercion or violence.

I will resist peer pressure to try drugs and alcohol.

I agree not to use a cell phone or text message while driving and to always use a seat belt.

Share these with family, friends, and coworkers. Would they agree? Would our students agree? Do a lesson on these and compare it to the national average. I would be very interested to hear back from you.

### NYSUT Legislative Representative, Peter Savage –55/25 Initiative

An update on the 55/25 incentive is being offered for this school year. [This would allow certain individuals age 55 and older with at least 25 years of service to retire with no reductions, if retirement occurs within an established window.] Peter reported that the bill has been formalized and will be presented to the Legislature for enactment by Feb. 1-6. He reported the legislation for this bill should be in effect by the end of March. NYSUT, however will be pushing to have this bill passed as quickly as possible due to the short window of time until the end of the school year. When asked if the 55/25 would be extended for the next school year we were told that unfortunately this initiative is a one-time proposition. You became a member of NYSUT, our state affiliate, when you joined the Association and your membership continues. When you retired, the Association submitted your name to NYSUT and you became a member of the ED10 Retirees Council. You will receive a newsletter and can become actively involved by attending meetings at the NYSUT headquarters in Latham. Your membership card continues to be valid and you are entitled to the many services NYSUT offers.
